- Sealed tenders are invited for Annual Repair/Special Repair Work (AR/SR) at Govt. Technical Training Institute, Tehsil (1) Road Jhelum based on already approved rates 2023 (MRS,1st-BI-Annual-2023) available on website of Finance Department, Govt. of the Punjab, from registered civil contractors.
- (2) The tendering process will be according to PPRA Rules 2014.
- The Tender fee Rs. 1,000/-(Non-Refundable) will be deposited in The Bank of Punjab Jhelum Cantt Branch (0033) in (3) Institute non-salary Bank Account No.CPA 6580066059600060 and deposit slip will be attached with request of tender issuance.
- Complete terms and conditions are mentioned in the tender form. (4)
- (5) Conditional tenders/bids will not be accepted.
- Contractors/bidders have to submit bid security in shape of Call Deposit Receipt (CDR) of amount Rs. 14,841/-(6) (Not Exceeding @ 5% of the Total Estimated Amount i.e., Rs.296,820/-) in the name of account (Non-Salary Govt. Technical Training Institute, Jhelum).
- Tenders/bids forms duly filled and signed on each page by the contractor shall be submitted at the address as mentioned (7) below through registered post/ courier services. By-Hand and tenders received after due time / date will not be accepted.
- The tender forms/bids deposited without or less bid security will not be processed. (8)
- The bidder will attach the PEC registration certificate showing the maximum limit of work. (9)
- (10) The contractor / firm will complete the AR/SR work according to the terms/conditions mentioned in the tender form, otherwise contract will be cancelled and bid security will be forfeited.
- (11) 10% Performance Security amounting to Rs. 29,682/- will be required in the name of account (Non-Salary Govt. Technical Training Institute, Jhelum), before awarding the contract that will be returned back at the completion of said AR/SR Work according to the period mentioned in the PPRA Rules 2014.
- Any cutting, erasing and amendment in the tenders/bids will not be accepted. (12)
- The decision of AR/SR committee will be final and cannot be challenge at any forum. (13)
- (14) Any public representative / journalist may observe the tender opening process.
- (15) (i) The AR/SR committee may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.
 - (ii) The AR/SR Committee will communicate the grounds of rejection of all bids or proposals, but shall not be required to justify those grounds.
 - (iii) The AR/SR Committee shall incur no liability, solely by virtue of its invoking sub-rule towards the bidders.
 - (iv) The bidders shall be promptly informed about the rejection of the bids, if any.
