- 2. The complete tender in all respects along with earnest money @ 2% of the estimated price in the shape of CDR, pay order or banker's cheque in favor of the District Manager, District Khanewal-Vehari must be submitted as per schedule given below.
- 3. The proposal / tender should consist of two envelops financial proposal / bid and technical proposal / bid, financial bids of only those bidder will be opened whose technical bid found approved/responsive.
- 4. The procurement committee may reject all bids or proposal at any time prior to the acceptance of bids/proposal as per clauses of PPRA rules -2014.
- 5. The payment will be made through cross cheque after deduction of all type of applicable taxes as per prevailing rates applicable at the time of payment after the satisfactory inspection & acceptance report in accordance with the given specification by the inspection committee.
- 6. Rates must be quoted inclusive prevailing tax rates.
- 7. Black listed firms need not to apply.
- 8. The bidder must be active tax payer as per FBR active tax payer list.
- Registration for bidding documents is mandatory, bidding documents available on PPRA web are only for information bid can only be submitted on the bidding documents obtained from the office of the undersigned.
- 10. The procurement process will be governed under Punjab procurement ruls-2014, Bid Validity: 90 Days after the bid opening date.
