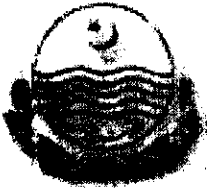

No. MD(PPRA)10-1/2011. In exercise of the powers conferred under rule 21 of the Punjab Procurement Regulatory Authority Rules 2014, the competent authority is pleased to approve the following mechanism and manner of blacklisting of a contractor by PPRA as a Procuring Agency.

The Managing Director, PPRA may on information received from any resource direct issuance of show cause notice to a bidder or contractor of the Procuring Agency.

2. The show cause notice shall contain precise allegation against the contractor and maximum period of debarring the contractor from participating in any public procurement of the Procuring Agency.

3. The contractor will be given minimum of seven days to submit the written reply of the show cause notice.

4. In case the contractor fails to submit written reply within the requisite time, the Managing Director may direct to issue notice of personal hearing to the contractor/ authorize representative of contractor and the Managing Director shall decide the matter on the basis of available record and personal hearing, if availed.

5. In case the contractor submits written reply, the Managing Director may decide to file the matter or direct issuance of a notice to the contractor for personal hearing.


6. The contractor shall be given minimum of seven days for appearance before the Managing Director for hearing in person.

7. The Managing Director shall decide the matter on the basis of available record and personal hearing of the contractor, if availed.

8. The Managing Director shall decide the matter within fifteen days from the date of personal hearing unless the personal hearing is adjourned to a next date and in such an eventuality, period of personal hearing shall be reckoned from the last date of personal hearing.

9. The order of Managing Director shall be communicated to the contractor with a statement that the contractor may, with thirty days, file a representation against the order before the Chairman, Board of Management of PPRA/ Chief Secretary, Government of the Punjab.


10. An effort shall be made for electronic communication of the notices and other documents pursuant to this mechanism and manner of the blacklisting of the contractors.
