- a) Your services will be **on contract** basis under approved rules / regulations of TEVTA as issued / amended from time to time by the authority initially for a period of three years extendable from time to time up to the age of 60 years subject to satisfactory performance by reporting officer, revocable by either of the parties with one month notice or on payment of one month pay in lieu thereof. In case of misconduct your services will be terminated without any notice.
- b) Your designation, responsibilities or duties and place of date may change from time to time at the discretion of the Authority.
- c) Your appointment will be station / Institution specific and non-transferable anywhere in the Punjab. However the Authority has the right to change duties/assignments and the place of duty on administrative grounds.
- d) You will produce duly attested copies of your educational / testimonials, character certificate from the head of academic institution last attended/head of organization last served, NIC and domicile along with two photographs and Medical Fitness Certificate issued by Medical Superintendent of Services Hospital Lahore or concerned District Headquarters Hospital, at the time of your joining.
- This appointment shall be subject to verification of personal data prior to or after the appointment. If at any stage it is discovered that you had obtained the appointment on the basis of forged/bogus documents or through deceit by any means, the appointment shall be considered to be void ab-initio and you shall be liable to refund all amounts received from the TEVTA as a consequence of appointment, in addition to such other action as may be taken against you under the law.

- f) The appointment shall be subject to further condition of verification of **antecedents** by the Police Department if not already in Government Service.
- g) You shall perform your duties efficiently, diligently and to the best of your abilities. You shall not engage directly or indirectly in any trade, business or occupation on your own except as may be permitted by the Authority in writing and shall not absent yourself (except as in emergency, such as illness, accident etc.) from your duties without having first obtained permission from competent Authority.
- h) You will not divulge directly or indirectly to any person or body any knowledge or information, which you may account concerning the affairs, property, enterprise and undertaking of the Authority including its business and other matters.
- i) Unless the period of contract is extended by the competent authority, you will stand relieved on the expiry of contract period.
