### **NOTIFICATION**

Subject: GRANT OF AD-HOC ALLOWANCE-2010 @ 50 % OF EXISTING BASIC PAY AND MEDIAL ALLOWANCE.

No. TEVTA/Bud/Ad-hoc/2010/775: In pursuance of Finance Department, Government of the Punjab letter No.FD.PC-2-2/2010 dated 15-07-2010, the sanction is hereby accorded to allow Ad-hoc Allowance 2010 @ 50 % of the existing of Basic Pay to all Civil Servants, PSIC employees, TEVTA employees on contract, TEP employees on contract and Contingent Paid Staff of TEVTA as per following rates with effect from 01-07-2010:

#### 2- The amount of this Adhoc Allowance:

- i. Will be subject to Income Tax.
- ii. Will be admissible during leave and entire period of LPR except during extra ordinary leave.
- iii. Will not be treated as part of emoluments for the purpose of calculation of pension /gratuity and recovery of House Rent.
- iv. Will not be admissible to the employees during the tenure of their posting/deputation abroad.
- v. Will be admissible to the employees on their repatriation from posting / deputation abroad at the rate and amount which would have been admissible to them had they not been posted abroad.
- 3- The term "Basic Pay" for the purpose of Ad-hoc Allowance-2010 will also include the amount of the personal pay granted on account of annual increments beyond the maximum of the existing pay scales.
- 4- The medical Allowance in lieu of Outdoor Treatment and reimbursement of medical expenses has been granted as under:

S.No	BPS	Existing Rate	BP\$	Revised Rate
1	1-16	Rs.500/-p.m	1-15	Rs.1000/-p.m
11	17-22	Nil	16-22	15 % of basic pay

#### Note:

The existing facility of reimbursement of amounts spent on account of purchase of medicines by Government Servants and local purchase of medicines by Government Hospitals for Outdoor Patient (OPD) will be discontinued. However, the existing facilities for consultation and diagnostic investigations at OPD will continue as before. Reimbursement / Local Purchase on account of Cancer, Hepatitis B, C and Insulin

dependent diabetics would be admissible for OPD patients. The existing facility of reimbursement of all kinds of expenditure on account of Indoor Medical Treatment will continue as before.

b) The above medical allowance is not aomissible to TEVTA contract employees.
