2. Tender documents may be obtained up to **25/04/2019 at 10:00 AM** during the office hours from the office of the Manager, Govt. Technical Training Center, Hafizabad on payment of tender cost **Rs. 300/-(Non Refundable)** against written request accompanied by attested copies of updated renewal of PEC license, NTN Certificate, authority letter on the pad of Contractor/firm, copy of CNIC of Contractor/Managing Partner of the firm, power of attorney and affidavit that the firm is not black listed from any Govt/Semi Govt. Department.
3. The Contractor/ firm must be GST & NTN Registered. In case of exemption, proof should accompany the quotations.
4. Tenders will be received through registered post/courier up to **25-04-2019 till 10:00 AM** and tenders will be opened on the same day at **11:00 AM** in the presence of AR/SR committee.
5. Rates must be inclusive of all Taxes payable by Supplier. If contractor is registered with PRA and active then 16% PRA Sales Tax will be withheld and paid by the institute. And if contractor is not registered with PRA and not active then 16% PRA Sales Tax will be deducted from the contractor bill.
6. Payment will be made through cross cheque after deduction of all types of Government taxes and duties as per prevailing rates. Inspection and acceptance of the items must be in accordance with the given specifications.
7. Payment will be released subject to satisfactory report of inspection/AR-SR committee.
8. The competent authority may reject all bid or proposal at any time prior to the acceptance of bid or proposal.
9. Earnest money (refundable after completion and inspection of required work) **@ Rs.2% (2111/-) of the estimated price** will be deposited by the bidder with the quotation – through CDR/DD/PO in the name of **Manager Govt. Technical Training Centre, Hafizabad.**
